# 2016

#### 2016 was a year of growth.

#### **Funding:**

**Dane County CASA** earned a new Department of Justice grant for Victims of Crime. This growth solidified our current services but allows us to grow from serving 1/3 of the children under the protection of the courts due to abuse/ neglect, to serve up to 1/2 of these children. We still have room to grow and one day want to be able to say we serve EVERY child that needs this service.

**Oasis** increased its funding from the Department of Justice for Victims of Crime. This grant allows us to offer crisis counseling for families between the time they come for a forensic interview with Safe Harbor CAC and when they are placed in more long-term services; continue to serve Latino-families, provide services to others collaterally affected by the abuse who are or may become a person of support for the victim, once again provide group therapy services for adult survivors of childhood sexual abuse, and go into the schools to help middle school children learn about good touch/secrets vs. bad touch/secrets and who they can go to if they are being sexually abused. This last endeavor is so important because studies show that 1 in 4 girls and 1 in 6 boys will be sexually abused by the time they reach the age of 18.

**Parent to Child** increased funding from the Dane County Department of Human Services to allow this pilot project to increase our pool of volunteers and interns to provide services to more families in need of supervised visitation.

#### Staff:

CASA + 1.5 staff Oasis + 2 staff Parent to Child +.5 staff

#### Space:

With new staff comes a space crunch. As a temporary fix, we moved some of our programs and administrative staff into offices at Trinity Lutheran Church. The Parent to Child program was able to offer services at the church for several families. This also gave the Oasis program, which remains at our East Washington office, the space they need to provide therapy services to more children, teens, non-offending parents/caregivers, and adults.

2016, a year of growth, about sums it up...

Stay tuned for 2017 and 2018 - things to look forward to: new website in 2017, new office space in 2018, more visibility for the agency and services; but most importantly, more services to vulnerable individuals and families in all of our programs.

## PARENT STRESSLINE

The **PARENT STRESSLINE** is a confidential and anonymous service available from 8:00am to 10:00pm **daily** for parents and caretakers who are experiencing stress, need family resources, or who just need someone to listen. In the early morning hours and the late evening and night, when other resources are not available, the Parent Stressline provides immediate access to direct service. The

Parent Stressline is an effective measure in reducing the stress in families that can lead to child abuse and neglect. The Parent Stressline is available in English with a weekly Spanish language shift. In 2016, our Parent Advocates answered **2087 calls** on the Parent Stressline.









### SEXUAL ABUSE TREATMENT for children

**147 children** received sexual abuse treatment in 2016, through weekly group and individual therapy in our **Oasis Program**. Oasis therapists provide individual thera-

py to children (from birth to 18 years old) who have experienced incest and sexual abuse using quality trauma-focused and play therapy. Oasis offers groups to children from elementary through high school ages. Alongside structured learning opportunities, group members experience the benefit of sharing personal experiences with peers of a similar age. Individual services are provided in English and Spanish.





### **SEXUAL ABUSE TREATMENT** for non-offending parents



**74 adults** received weekly group therapy for non-offending parents and caregivers of children who have been sexually abused. Group therapy helps caregivers learn how to respond to the particular trauma-based needs of their children as well as to learn effective and protective strategies to parent their child in the aftermath of abuse. Groups in particular are beneficial for caregivers to see that they are not alone, this has happened to other families, and that there are others who understand from a very personal perspective.

### DANE COUNTY CASA

In 2016, 125 Court Appointed Special Advocate (CASA) volunteers served as the eyes of the court as they met weekly with their assigned child who was under the protection of the court due to child abuse/neglect and provided reports to the courts to aid in each child's safety, well-being and permanency. 96 children and teens were provided with 7,879 hours of services over the course of the year.

Teens served by the Dane County CASA program require support around gaining independence both in building skill sets (ex. financial or healthcare management) as well as opportunities (ex. college visits or obtaining a drivers license). Through funding provided by Attic Angels in the first 3/4 of the year and continued through general funds, CASA volunteers were better equipped to provide this support in 2016.

In October of 2016 Dane County CASA began receiving funding from the Department of Justice through a Victims of Crime Act grant. This grant both provides a foundation for the services offered, as well as the ability to expand the number of children served annually. Between October and December of 2016 this grant made it possible to grow from a staff of 2.5 to a staff of 4 which allows for the support of more volunteers who can in turn serve more children.





The Canopy Center provided community education on issues related to parental stress, parenting, child abuse and neglect and child sexual abuse. In 2016, we provided 32 workshops and conferences reached 509 people in Dane County and across the country.

### **COMMUNITY EDUCATION**



In July 2011, Canopy Center and Safe Harbor Child Advocacy Center co-located to a new space on E. Washington Avenue. With complementary programming and space needs, each agency is able to more fully carry out our missions and serve our community.

### COLLABORATION

Canopy Center also collaborated with Trinity Lutheran Church to allow us to provide our Families United Network program in their spacious building, with full commercial kitchen.
